SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. APPLICATION PROCESS FOR LEA ALLOCATIONS OF ARP-ESSER SEA RESERVE FUNDS

The federal ARP statute requires SEAs to reserve:

not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

The 2021-22 enacted state budget directs that these required SEA set-asides be allocated as grants to specified school districts. NYSED will inform school districts under separate cover when the application process for school district allocations of ARP-ESSER SEA set-aside funds has been published in the [SED Monitoring and Vendor Reporting System](#). Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. An SEA must allocate at least 90 percent of its ARP ESSER grant funds to its LEAs (including charter schools that are LEAs) in the State in the same proportion that the LEAs received under part A of title I of the ESEA in Fiscal Year 2020, as required by section 2001(d)(1) of the ARP Act; and section 2001(e) of the ARP Act prescribes certain mandatory and permissive uses of LEAs' funds. Under 20 U.S.C. 1221e-3, the Secretary has the authority to promulgate rules governing the programs administered by the Department. THE PLAN PROVIDES FOR THE SUPPORT OF A CONTRACTED SECURITY SERVICE TO MONITOR DOORS AND EXTERIOR ENTRANCES TO ALLOW FOR INCREASE VENTILATION. THERE ARE TECHNOLOGICAL PROPOSED PURCHASES TO BETTER UTILIZE LARGE GROUP INSTRUCTION AREAS TO MAKE SURE THAT STUDENTS ARE SPACED SAFELY. THE TECHNOLOGICAL UPGRADES WILL ALSO ALLOW A ONE TO ONE DEVICE INSTRUCTION THAT ENABLES TEACHERS TO CONDUCT SMALL GROUP INSTRUCTION IN PERSON WITH SPACING AND ALSO VIRTUAL INSTRUCTION IF NEEDED.

THE LEA WILL IMPLEMENT AN RTI PROGRAM THAT USES AIMSWEB PLUS WITH THE SUPPORT OF A PLANNED FULL-TIME RTI COORDINATOR TO OVERSEE THE PROGRAM BY COLLECTING DATA, IDENTIFYING STUDENTS WITH LEARNING GAPS OR AT-RISK OF LEARNING GAPS. THE RTI COORDINATOR WILL ALSO DEVELOP AN INDIVIDUALIZED PLAN FOR EACH STUDENT. THIS INCLUDES ENL STUDENTS, SWD STUDENTS, AND GENERAL EDUCATION STUDENTS. AIMSWEB PLUS MEASURES ENGLISH LANGUAGE ARTS SKILLS IN VOCABULARY ACQUISITION, SILENT READING FLUENCY, ORAL READING FLUENCY, AND READING COMPREHENSION. IN MATHEMATICS STUDENTS ARE MEASURED IN MENTAL MATH FLUENCY AND CONCEPTS AND APPLICATIONS. THEY ARE MEASURED USING A STANDARDIZED SCORE THAT COMPARES THEIR LEVEL OF ACQUISITION TO ALL STUDENTS NATIONWIDE. THIS PROVIDES A BENCHMARK SCORE. THE INDIVIDUALIZED PLAN IS THE PLAN IS CREATED BY SETTING A RATE OF IMPROVEMENT GOAL AND MEASURED EVERY TWO WEEKS. IF PROGRESS IS NOT MADE OR STUDENTS OR STUDENTS SCORE BELOW THE NATIONAL RANK OF 26% THEY RECEIVE DIRECT SMALL GROUP INSTRUCTION. IN ADDITION TO THE DIRECT INSTRUCTION THAT REMEDIATES THE IDENTIFIED DEFICIT SKILLS, STUDENTS RECEIVE AN I-READY ACCOUNT TO USE DURING THE SCHOOL DAY, AND OUTSIDE OF SCHOOL HOURS, AND ON WEEKENDS, EXTENDED BREAKS. THE LEA PLANS TO CONTINUE TO USE I-READY FOR THE TWELVE-MONTH CALENDAR YEAR TO MAINTAIN STUDENT SKILLS THROUGHOUT THE SUMMER. A CBO WILL BE CONTRACTED TO ASSIST WITH THE IMPLEMENTATION FOR STUDENTS IN NEED AND TO PROVIDE ON-GRADE LEVEL STUDENTS WITH ENRICHMENT. TO PAY FOR THE FTE TO SERVICE STUDENTS FOR THREE YEARS FROM 2021-2024.

THE LEA IS PLANNING TO USE A CBO TO CONTINUE TO PROVIDE SUMMER LEARNING AND ENRICHMENT TO ALL STUDENTS AS CREATED THIS YEAR AND FOR THE NEXT THREE SUMMERS ENDING 2024.

THE ELA WILL USE THE FUNDS TO INCREASE THE TECHNOLOGICAL INFRASTRUCTURE BY CREATING A ROBUST NETWORK TO PROVIDE IN-SCHOOL SPEED AND VIDEO BANDWIDTH SO THAT STUDENTS CAN BE SUPPORTED BY A ONE-TO-ONE DEVICE INITIATIVE. IF SCHOOL IS CLOSED, STUDENTS WILL ALSO BENEFIT FROM THE NETWORK BY LOGGING INTO A VIRTUAL DESKTOP TO ALLOW FOR A ASYNCHORNIS LEARNING AND AN ALL VIRTUAL SCHOOL. TEACHERS WILL RECEIVE ENHANCED PROFESSIONAL DEVELOPMENT TO IMPROVE THEIR SKILLS IN THE SCIENCES AND WITH STUDENTS WHO ARE NON-ENGLISH SPEAKERS.

THE ELA WILL USE TWO MAIN INSTRUMENTS TO MEASURE STUDENTS SOCIAL AND EMOTIONAL NEEDS AND THEIR ACADEMIC PROGRESS. THE ELA USES A ROBUST RTI PROGRAM AT THE ELEMENTARY AND SECONDARY LEVELS TO MEASURE STUDENTS' PROGRESS. THIS PROGRAM IS RECOGNIZED BY NYS THROUGH A MIDDLE SCHOOL RTI MODEL SCHOOL AND BY THE NATIONAL BLUE RIBBON SCHOOLS AWARD. ALL STUDENTS (SWD, ELL, LOW-INCOME) ARE SCREENED TWO TIMES EACH YEAR TO ENSURE THAT IF THEY ARE BELOW BUILDING TARGETED GOALS (NATIONAL 26% PERCENTILE OR LESS) ARE ENTERED INTO THE RESPONSE TO INTERVENTION PROGRAM AND RECEIVE AN I-READY ACCOUNT, AND IF NEEDED DIRECT INSTRUCTION FROM THE RTI COORDINATOR. THE PPS STAFF SURVEYS STAFF MEMBERS TO MEASURE STUDENTS EMOTIONAL WELL-BEING BY ASKING STAFF AND PARENTS TO COMPLETE A SURVEY REGARDING STUDENT BEHAVIOR. THE DISTRICT, WHILE NOT USING THE GRANT, IS USING GENERAL FUND MONEY TO INCREASE THE PPS STAFF BY A .5 FTE TO PROVIDE THREE FULL-TIME COUNSELORS/PSYCHOLOGISTS THAT REDUCE THE COUNSELOR TO STUDENT RATIO FOR THE UPCOMING SCHOOL YEAR, 2021-2022. STUDENTS FROM LOW-INCOME FAMILIES WHO TEND TO ALSO BE ELL STUDENTS ARE PROVIDED WITH A CHROME BOOK TO GIVE THEM ACCESS TO THE I-READY PROGRAM. THE LAPTOP LENDING APPLIES TO ALL STUDENTS WHO HAVE DEMONSTRATED RESOURCE NEEDS.

Section 2001(i)(1) of the ARP Act requires each LEA that receives ARP ESSER funds to develop and make publicly available on the LEA's website, not later than 30 days after receiving ARP ESSER funds, a plan for the safe return to in-person instruction and continuity of services for all schools, including those that have already returned to in-person instruction. Section 2001(i)(2) of the ARP Act further requires that the LEA seek public comment on the plan and take those comments into account in the development of the plan.
